PRODUCT DATA REQUIREMENTS WHEN USING INTERTRADE'S CATALOGUE

Vendors have the option of providing product data (attributes) and content directly through the use of **ecCatalogue**, that enables the efficient flow of product attributes through direct integration to our PIM system. By **providing Indigo with access** to their respective Catalogues and completing a set of **mandatory attributes**, vendors and merchants can take advantage of **integration and automated workflows** for faster and more accurate product onboarding & updates.

This option will eliminate the need for vendors to load and update product data directly in PIM, as that can all be managed in the Catalogue.

CATALOGUE REQUIREMENTS FOR INDIGO

Indigo requires vendors to complete a set of **mandatory attributes**.

Please refer to the **Appendix** for the detailed list of mandatory attributes for ecCatalogue.

For product data to flow to Indigo's PIM system, all mandatory attributes MUST BE COMPLETED.

Please note, this list may be updated as required and communicated to vendors accordingly.

TRACKING COMPLIANCE IN ECCATALOGUE

There is a compliance tracking functionality within ecCatalogue that indicates a GTIN's level of compliance with Indigo's data requirements. 100% compliance indicates that a GTIN is ready to be selected by the Indigo merchant and trigger integration with PIM.

Anything less than 100% compliance will require data completion for the integration to occur.

Indigo Compliance Rules (in ecCatalogue)

The 29 attributes below are measured in the Catalogue compliance tracker with the severity level below:

• Error: data will NOT flow into Indigo's PIM system until all attributes are completed

Alternatively, if vendors are unable to provide French content, Indigo will complete the translation for the respective vendors and will charge the total fee of the translation service (charged by the 3rd party translation service provider) in addition to the Missing Item Description (French) chargeback fee (per UPC) to the respective vendor (see data compliance table below).
