The sender of this transaction is the organization responsible for detailing and communicating the contents of a shipment, or shipments, to one or more receivers of the transaction set. The receiver of this transaction set can be any organization having an interest in the contents of a shipment or information about the contents of a shipment.

Sprouts Farmers Market - Stores will use this information as confirmation and content details of the shipment in advance of the receipt of the orders.

Sprouts Farmers Market - Stores will support the Pick and Pack ASN Structure and each ASN will represent a single shipment (ship-to location). A new ASN must be sent for each Purchase Order physically in a single Shipment/Trailer/Container, with the tracking number repeating (only a single order per ASN).
